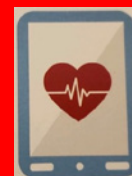

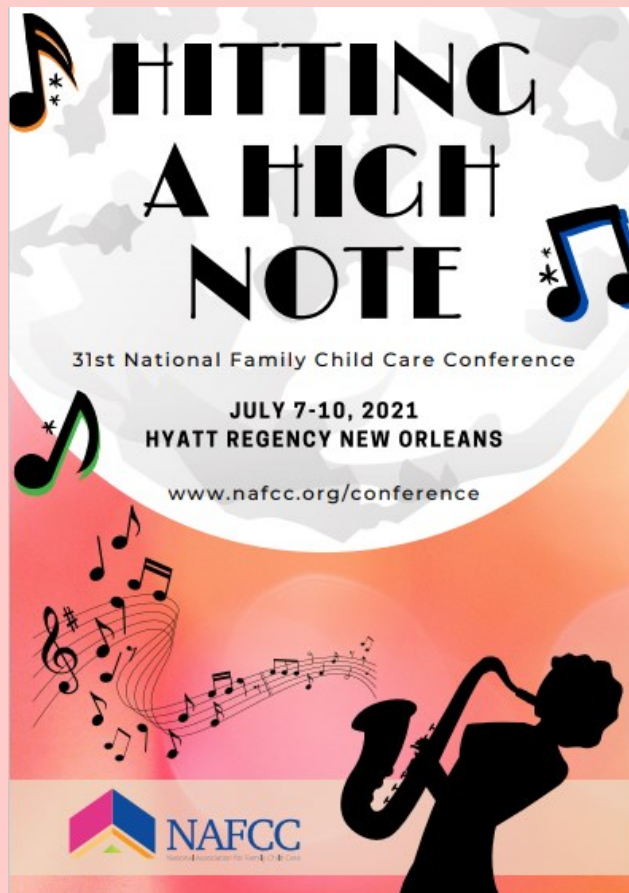

Legislative News

Lynn Gibson, Legislative Liaison

FFCCHA has been non-stop advocating for all Family Child Care Providers for the past year. We went into high gear these past 3 months, participating in about 6 meetings a week for me, and additional meetings for Tammy Tener. FFCCHA has been speaking out in all forums to make sure that Family Child Care Providers were not forgotten when it came to funding.

We have had success! During 2020 the child care advocates secured **10 Billion** dollars for child care providers. We were told it was a down payment and more was to come. Being honest, we know politics and how things can change as time goes on, FFCCHA joined together with other associations across the state and across the nation. Each of you were too important to have the funding stop, we needed to make sure that you were going to make it for the next year and the year after that.

Together with NAFCC, NAEYC, and FLAEYC, we attended every meeting we could, we spoke up during meetings and became an important piece of the pie. During the month of March, prior to the vote for the "rest of the payment" that we were told was coming, we attended meetings with legislators and their staff in Congress. Each meeting left us feeling our voice was heard and, in the end, we proved it had been. All 40 Billion dollars was funded in the bill and we got our asking price... \$50 Billion dollars over the past year for Child Care Providers. HUGE!! We did not ask for funding just for licensed or school readiness providers, we included registered and private-pay providers as well.

I've also reached out to Florida House of Representative Erin Grall, the sponsor of HB 419, asking that while the legislators have the statutes dealing with Early Learning Coalitions opened up to vote on, that they look into making changes that add the position of a Family Child Care Provider to each one of the ELCs. We need to have a voting voice on these boards. We here at FFCCHA will continue to hold up our heads, take in deep breaths and speak out - even if our voices shake - to make sure that providers are not forgotten EVER again.

Best Practices to Talk with Young Children About COVID-19

While people around the world are taking precautions to protect themselves, their families, and their communities from the coronavirus disease (COVID-19), it's also important that young children can continue to learn, and that they can do so in an environment that is welcoming, respectful, inclusive, and supportive to all. Child care Providers play a vital role in this. Therefore, it is important that those caring for young children are able to share information about COVID-19 without creating additional stress in young children.

Here are some suggestions about how providers can engage and teach younger children of preschool age on preventing and controlling the spread of COVID-19 and other viruses. Any conversations or activities should always be age appropriate. The conversation does not need to be scary.

- Make sure to listen to children's concerns and answer their questions in an age-appropriate manner; don't overwhelm them with too much information.
- Encourage them to express and communicate their feelings. Discuss the different feelings they may be experiencing and explain that these are normal reactions to an abnormal situation.
- Focus on communicating good health behaviors, such as covering coughs and sneezes with the elbow and the importance of hand washing.
- Encourage regular handwashing, for at least 20 seconds.
- Find ways to reward them for frequent/timely hand washing.
- Use puppets or dolls to demonstrate symptoms (sneezing, coughing, fever), what to do if children feel sick (like if their head hurts, their stomach hurts, or if they feel hot or extra tired).
- Emphasize that children can do a lot to keep themselves and others safe. For example, introduce the concept of physical distancing (standing further away from friends, avoiding large crowds, not touching people if they don't need to.)

In the end, if a child is struggling with fears about the coronavirus, be reassuring to them that all precautions are being taken to keep them safe.

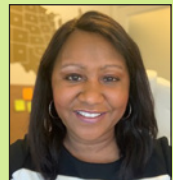

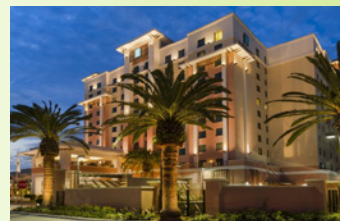
